

Trane Complete System Giveaway Promotion

No Purchase Necessary. A Purchase Will Not Increase Your Chances of Winning.

1. Sponsors and Agreement to Official Rules. The Trane Complete System Giveaway Promotion (“Promotion”) Sponsors are Trane U.S. Inc. (“Trane”) and Richmond Flying Squirrels (“RFS”) (each, a “Sponsor” and collectively, “Sponsors”). By participating, entrants agree to abide by and be bound by these Official Rules and the decisions of the Sponsors, which are final and binding in all matters relating to this Promotion. Winning the prize specified herein is contingent upon fulfilling all requirements set forth in the Official Rules.

2. Eligibility. The Promotion is open only to individuals who (i) are legal residents of the United States residing in Virginia, excluding the following cities and counties: Alexandria, Arlington, Bath, Bland, Craig, Fairfax, Fauquier, Frederick, Giles, Grayson, Highland, Loudoun, Page, Prince William, Rappahannock, Shenandoah, Warren, and Wythe, (ii) are eighteen (18) years of age or older on the date of the Promotion entry submission, and (iii) own their primary residence. Trane, RFS, and Minor League Baseball (“MLB”) employees and any of their affiliate companies, subsidiaries, agents, and advertising and promotional agencies, as well as the spouse, parents, siblings, children, and household members of each such employee are not eligible. **Void outside Virginia and where prohibited by law.** All federal, state/provincial, and local laws and regulations apply.

3. Promotion Period. The Promotion begins at 5:30 p.m., Eastern Standard Time, on June 2, 2026 and ends at 12:00 a.m., Eastern Standard Time, on July 26, 2026 (“Promotion Period”). All entries must be received by 12:00 am eastern time on July 26, 2026. Entries submitted before or after the Promotion Period will not be eligible. RFS Sponsor’s computer is the official time-keeping device for the Promotion.

4. How to Enter. Subject to the Eligibility requirements above, to receive an entry into the Promotion during the Promotion Period, visit the following link – <https://www.milb.com/richmond/fans/contest> – and submit an entry form. Each entrant will be required to provide full name, address (including zip code), e-mail address, telephone number, and date of birth. Upon completion of the entry form, each entrant then will be entered into the random online drawing stated in these Official Rules. **All required information must be provided to enter and be eligible to win. Incomplete and non-accurate entries will be disqualified.** Only one (1) entry is permitted per person and per household. Any attempt to submit or obtain more than one (1) entry by any method, including through the use of multiple email addresses, is prohibited, and Sponsors reserve the right in their sole discretion to disqualify any such entries. 5. Random Promotion Drawing. The Sponsors will conduct a random online drawing within five (5) business days immediately following the expiration of the Promotion Period. One (1)

winner will be selected by random online drawing from all eligible entries received within the Promotion Period. Odds of winning depend upon the number of eligible entries received. **A purchase of Trane's products or RFS' products will not increase the odds of winning.** Winner must meet all eligibility requirements, including the execution and delivery of all necessary releases. All Promotion entries are subject to verification by Sponsors, whose decision is final and binding in all matters relating to the Promotion. Sponsors will not accept screen shots or other evidence of winning in lieu of its validation process. Any entry that occurs after the system has failed for any reason is deemed a defective entry and is void and will not be honored.

6. Notification and Requirements of Potential Winner. The potential winner will be contacted by Sponsor RFS by telephone or e-mail on or after 12:00 a.m., Eastern Standard Time, on August 1, 2026 and may be required to sign and return an Affidavit/Declaration of Eligibility and Liability and Publicity Release within ten (10) days of initial notification. If any attempted notification is not successful within ten (10) days or if a potential winner fails to sign and return the requested documents within the required time period, the prize will be forfeited, and Sponsors reserve the right to randomly select an alternate winner from among the remaining eligible entries. Sponsors are not responsible for incomplete, lost, late, damaged, illegible, or misdirected email. The winner must comply with all terms and conditions of these Official Rules, and winning is contingent upon fulfilling all requirements. The winner of the Promotion prize who meets all of the Eligibility requirements, is verified, and has fully complied with these Official Rules, will receive the prize on a date to be determined by Sponsor Trane in its sole discretion.

7. Prize. The prize includes one (1) Complete system – selected by Sponsor Trane in its sole discretion – consisting of one (1) outdoor unit, one (1) indoor unit, and one (1) thermostat, with a system rating of 17 SEER or less and a capacity of five (5) tons or less. One-time installation of the system is included; however, such installation shall be performed by an independent third-party dealer selected solely by Sponsor Trane in its sole discretion. Sponsor Trane shall have no obligation to select any particular dealer and makes no representation or warranty regarding the services of any installing dealer. Installation must be completed at a residence and location in Virginia, not excluded in the Eligibility requirements, and must be scheduled and completed within the timeframe specified by Sponsor Trane or the prize may be forfeited. Zoning, ductwork, electrical work, code upgrades, permits, patching, painting, carpentry, condensate upgrades, line-set replacement or modification, venting, drain modifications, accessories, repairs to pre-existing conditions, and any and all other items or services not expressly stated herein are specifically excluded from the prize. The prize winner is solely responsible for site access and all costs and expenses associated with acceptance, use, ownership, and maintenance of the prize. Additionally, the prize winner is responsible for paying any applicable federal, state, and local taxes and all other costs and expenses not listed herein. All prize details not specified, including without limitation brand, model, efficiency rating, components, dealer, installation scope, and timing, shall be determined by Sponsor Trane in its sole discretion. The prize has an estimated approximate retail value (“ARV”) of \$25,000. Actual value may vary depending on installation location and market conditions, and the difference, if any, will not be awarded. The prize is nontransferable. There are no cash alternatives, substitutions, or alternative prizes permitted, except by Sponsor Trane, for any reason. Sponsor Trane reserves the right, in its sole discretion, to substitute the

prize or any component thereof with a prize or component of equal or greater value if the advertised prize or any portion thereof becomes unavailable for any reason.

8. Privacy and Publicity. Any information you submit as part of the Promotion will be used for purposes of the Promotion and treated in accordance with Sponsors' privacy policies, noted above. 10. General Conditions. In the event that the operation, security, or administration of the Promotion is impaired in any way for any reason, Sponsors may in their sole discretion, either (a) suspend the Promotion to address the impairment and then resume the Promotion in a manner that best conforms to the spirit of these Official Rules; or (b) award the prize at random from among the eligible entries received up to the time of the impairment. Sponsors reserve the right in their

sole discretion to disqualify any individual they find to be tampering with the entry process or the operation of the Promotion or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner. Any attempt by any person to undermine the legitimate operation of the Promotion may be a violation of criminal and civil law, and, should such an attempt be made, Sponsors reserve the right to seek damages from any such person to the fullest extent permitted by law. Sponsors are not responsible for any typographical, technical, or other error in the printing of the offer, administration of the Promotion, or the announcement of the winner. Failure by the Sponsors to enforce any provision of these Official Rules shall not constitute a waiver of that provision. If a provision is determined to be invalid or otherwise unenforceable or illegal, these Official Rules shall otherwise remain in effect and be construed in accordance with their terms as if the invalid or illegal provision were not contained herein.
